*Errors on Entry Blanks.* Owners are responsible for errors in the filling out of entry forms. No entry and no entry fee will be refunded in event of such errors, or for cancellation of entries after the published closing date. Please type or <u>print carefully</u> on entry forms to eliminate errors.

**Bitches in Season** will not be admitted to the Trial. Any exhibitor with an entered bitch in season on the trial date will be refunded the entry fee less \$10.00 (each day) upon written certification by a veterinarian given to the Trial Secretary before the start of judging.
